

**CITY OF AMERY
PUBLIC SAFETY COMMITTEE PROCEEDINGS
September 24, 2019**

The Public Safety Committee of the City of Amery met on Monday - September 24, 2019 at City Hall in the Committee Meeting Room. Chairperson, Kris Vicker called the meeting to order at 6:52 p.m.

Ordinances Discussion:

2 ordinances were presented for the committee to review. They covered Rental Housing Regulations and Drone/Unmanned Aerial Vehicle Usage.

Ordinance #22-2019 Rental Housing Regulations was presented. The committee saw no changes needed, and Police Chief, Tom Marson informed City Clerk-Treasurer, Bjorklund that the ordinance appeared to be fine with him.

Motion by Vice Chair-Person, Strobusch to make the recommendation for approval of Ordinance #22-2019 Rental Housing Regulations to Amery City Council at their October 2, 2019 City Council Meeting. Seconded by Member, Riemenschneider.

Ordinance #23-2019 Drone/Unmanned Aerial Vehicle Usage was presented. Police Chief, Tom Marson informed City Clerk-Treasurer, Bjorklund that the ordinance appeared to fine with him. Vice-Chairperson, Strobusch would like to see Fire Fighting and Law Enforcement included as an exception in their official capacity. He would also like it noted that FAA Regulations should be followed.

Motion by Vice Chair-Person, Strobusch to make the recommendation for approval of Ordinance #23-2019 Drone/Unmanned Aerial Vehicle Usage to Amery City Council at their October 2, 2019 City Council Meeting. Language will be included with the Public Safety Exception Clause as well as following FAA Regulations. Seconded by Member, Riemenschneider.
